INFORMED INVESTMENTS IN CYBER SECURITY - PRIORITY OF ALBANIA AND ITS STRATEGIC PARTNERS

NAECCS in cooperation with the US Department of State and MITRE Corporation organized the 3-day workshop "Senior Policymaker Cyber Strategy Planning". The purpose of the 3-day workshop was to finalize the development of the framework of a National Strategy for Cyber Security, which includes the definition of policy goals, the identification of supporting initiatives for each goal, the identification of actors for each initiative, and recommendations for challenges and their overcoming for the implementation of activities.



During these 3 days, the General Director of NAECCS Mr. Igli Tafa presented the new strategic vision of the Authority, which is based on 5 main pillars, as well as emphasized the commitment of Albanian institutions for coordination and cooperation to creating a safer cyber ecosystem. In this context, the General Director of the Authority also highlighted the need for cooperation with national and international strategic partners to strengthen cyber resilience in the country.

The 3-day workshop focused also on the role of each security and defense institution in designing security strategies and policies for managing cybersecurity issues, as well as harmonization of strategic plans with US best practices.

At the end of the workshop, the General Directorate of NAECCS and National Coordinator for Cyber Security expressed his gratitude for the organization of the workshop to the US Department of State and MITRE Corporation for their support and expertise.
