### Cybersecurity Audit at the Core of Training with Critical and Important Information Infrastructures



The National Cyber Security Authority (AKSK), in cooperation with DCAF, conducted a training session with representatives of critical and important information infrastructures, focusing on the implementation of cybersecurity measures and the application of relevant standards.

The training aimed to enhance professional capacities for conducting cybersecurity audits in line with legal requirements and international standards. It is part of a series of trainings that will continue throughout the year, supporting the strengthening of security across critical and important infrastructures.

Strengthening cooperation with universities is a key element of the vision of the National Cyber Security Authority (AKSK) for identifying young talent and building capacities in the field of cybersecurity. In this context, AKSK signed a cooperation agreement with Western Balkans University.

## AKSK Organizes Coordination Meeting with Law Enforcement Authorities

The National Cyber Security Authority (AKSK) held a coordination meeting with representatives of law enforcement authorities, focusing on strengthening institutional cooperation in the field of cybersecurity, in line with AKSK's vision of building a coordinated and sustainable approach to addressing cyber threats.

The meeting focused on presenting institutional capacities, discussing approaches to cyber incident management, and identifying opportunities for further cooperation through expertise sharing and technical coordination, with the aim of increasing readiness and strengthening institutional security at the national level.

## AKSK Training Expands to Schools through the Train-the-Trainers Model

Following the training organized by the National Cyber Security Authority (AKSK) for high school student councils, which provided practical knowledge on cyber hygiene and online safety, one of the trained participants delivered an awareness session at "Asim Vokshi" High School as part of the train-the-trainers program.

During the session, basic concepts of digital protection were presented, including the use of strong passwords, identification of suspicious content, safe behavior on social media, and everyday practices that enhance online security, within the framework of cooperation between AKSK and the OSCE Presence in Albania.



## AKSK Conducts Practical Cybersecurity Training for Students of Tirana College of Technology

The National Cyber Security Authority (AKSK) conducted a practical Cyber Drill for students of Tirana College of Technology, focusing on real-life scenarios and hands-on exercises for responding to cyber incidents in the digital space.

The activity aimed to strengthen students' knowledge and practical skills in cybersecurity through a practice-oriented approach and the exchange of professional expertise.



## Leiden University Students Conduct Study Visit to AKSK

Forty-five students from Leiden University in the Netherlands, enrolled in the Public Administration program, carried out a study visit to the National Cyber Security Authority (AKSK).

During the visit, students were introduced to Albania's practical experience in this field, focusing on institutional response, inter-agency coordination, and the role of public administration in the practical management of cyber situations, followed by discussions and questions related to their field of study.
